Narrative

On Monday, December 11, 2017 at 2:33 p.m. Deputy Israel Arguello #4639 was dispatched to the Hidalgo County Precinct #1, Sunrise Hill Park located just east of Mile 1 1 / 2 West Road, on Mile 11 North Road, to an address near, 5232 Mile 11 North Road, Mercedes, Texas in reference to a Burglary of Vehicle report.

Met with Jesse Casiano DOB: [REDACTED] age 43 who stated:

- He is the Maintenance Supervisor for Hidalgo County Precinct#1.
- His office purchase a blue in color, Odessa Brand water pump valued at \$940.28 in August of 2017.
- He remembers last seeing it inside an enclosed, white in color utility trailer on the property sometime in September of 2017.
- He noticed the water pump missing about 30 days ago but does not remember the exact day.
- The trailer was on the property with the water pump inside the trailer.
- The trailer is always closed and locked when not in use and five other employees had keys before it was missing.
- The front gate to the property is always closed and locked and there is always a security guard on watch duty for the property.
- He asked several of his employees and co-workers who have keys and none of them knew the whereabouts of the water pump
- He believes someone stole the water pump from the trailer.
- He is just now reporting the incident because administration is now aware of the missing water pump and needs to file a police report for the audit.
- Now only he and one other employee have keys to the trailer and the lock has been changed.
- He would like to file charges on behalf of the company.

Deputy's Actions / Observations:

- Arrived at location and obtained information for report.
- Observed an invoice for a purchase order of an Odessa Water Pump valued at \$940.28 with Model Number: 3932-95 and with Serial Number: 2331821.
- Observed that said water also had an Hidalgo County Asset Tag Number: 73702.
- Observed no forced entry or damages on said white in color, enclosed utility trailer.
- Observed no cameras on property.
- Provided complainant with a case number.
- Advised complainant to report any other incidents.
- Entered said stolen item into the system as stolen through Dispatch Officer Cabrera #3450 and received NIC: A304685547.
- No further action taken.
