Dear Judge and Commissioners:

Recommend that agreements/contracts be revised to include the County Auditor's signature as certification of available funds.

Recommend No Action: The invoices were not attached; therefore, we could not determine fiscal impact.

Recommend No Action: The Personnel Adjustment Request (PAR) forms were not approved by Human Resources and Department of Budget & Management.

Point of Information: The backup documentation for these two agenda items are switched.

Regular Agenda Item 21.A. (AI-63672) – Community Service Agency
Recommend No Action: The proposed amendment to the CEAP distribution model was not attached.

Regular Agenda Item 27.A. (AI-63819) – Precinct No. 2
Recommend No Action: The Resolution for North Alamo Village Ltd. was not attached. In addition, the Resolutions commit the County "to an in-kind contribution to the Housing in the form of a loan, grant, reduced fee or contribution of other value for the benefit of the Housing in the amount of \$500.00. Funding for the in-kind contributions was not identified.


Regular Agenda Item 30.B.3 (AI-63711) – Purchasing Department for Precinct No. 1

Recommend No Action: Pursuant to Local Government Code (LGC) Sec. 262.011 (d), "The county purchasing agent shall purchase all supplies, materials, and equipment required or used, and contract for all repairs to property used, by the county or a subdivision, officer, or employee of the county, except purchases and contracts required by law to be made on competitive bid. A person other than the county purchasing agent may not make the purchase of the supplies, materials, or equipment or make the contract for repairs." In addition, LGC Sec. 262.011 (f), states, "The county auditor may not draw and the county treasurer may not honor an electronic transfer, check, or warrant for a purchase unless the purchase is made by the county purchasing agent or on competitive bid as provided by law." Since the repairs were obtained without a purchase order (i.e., not approved by the Purchasing Agent), it is not in compliance with LGC Sec. 262.011 (d); therefore, the County Auditor is prohibited from processing payment on this purchase pursuant to LGC Sec. 262.011 (f).

Recommend No Action: The professional services agreement, ACORD Certificate of Liability Insurance, Certificate of Interested Parties (Form 1295), and legal counsel's review and approval were not attached.
