Dear Mr. Crain,

Thank you again for assisting us with our Dealer Deputy Contract agreements. We recently updated our WebDealer Contracts because of changes to the Texas Administrative code. The Bert Ogden dealerships would like to enter into the WebDealer Deputy agreement as it will entitle them to the new processing and handling fee. Dealer desires to act as agents of the County in the issuance of motor vehicle license registration stickers, license plates and in the application for vehicle titles. The dealership has obtained a bond in the amount of \$100,000 for each of the dealerships.

At this time we would like to formally request legal approval to proceed with this request from our Commissioners.

I am forwarding you a copy of the contract agreement, bonds and supporting documents.

These contacts appear to be in order and ready to be presented to our commissioners. If there are any concerns, please let me know.

There are also 2 additional dealerships Bert Ogden is interested in adding but have several inconsistencies in the DBA information provided. Those were not submitted to your office being that each has 2 two DBA names associated with the Corporations. The 2 two in question are Bert Ogden Motors Inc., DBA Bert Ogden Mazda and DBA Bert Ogden Motors GMC P13110 and also Fiesta Trenton Motors, Inc. DBA Volvo of Edinburg and DBA Volvo Cars Edinburg P115046. We expect to add these two dealers as soon as the names are clarified. If you have any questions, please feel free to ask.
