Yes, the Mazda bond has not been corrected. Because we do not have a date when it will be presented to commissioners court, the bond will need to be subject to review after the date of approval. I noticed that the bonds now say that this bond supersedes and replaces the previous bond. Dear Mr. Crain,

Thank you again for assisting us with our Dealer Deputy Contract agreements recently passed subject to final legal review. As you know, the Bert Ogden dealerships were approved on February 20, 2018 to act as agents of the County in the issuance of motor vehicle license registration stickers, license plates and in the application for vehicle titles. The dealerships have obtained bonds in the amount of \$100,000 for each of the dealerships. The dealer deputy has now submitted bonds with an effective date the day the contract was approved by our commissioners' court.

**At this time we would like to formally request final legal review and approval to commence the terms of the agreement.**

At the same time, our office has received a signed agreement for the pending dealership Bert Ogden wants contacted with the county. This is part of the 2 additional dealerships that had inconsistencies with the DBA information provided. This contact appears to be in order and ready to be presented to commissioners' court.

**At this time we would like to formally request legal approval to proceed with this request from our Commissioners.**

I am forwarding you a copy of the contract agreement, bond and supporting documents.
