Good Morning Ms. Ortiz,

As requested this office reviewed the six requirements agreements for medical supplies from various vendors for the WIC program. Each agreement is approved as to form with the inclusion of the following minor modifications in each agreement:

1. Add the phrase "(on an as needed basis)" in parenthesis after the word "County" in the second paragraph, and include quotations on the word "Product" on the same line. See highlighted language below:

WHEREAS, Buyer has solicited bids for the supply of required "Medical Supplies" for Hidalgo County (on an as needed basis) **(the "Products")**, as further described in the Request for Bid (RFB) Procurement Packet, which is attached hereto as Exhibit "A" and incorporated herein by reference for all purposes (the "RFB"); and

2. Add a period after the word "appropriate" in section entitled: *j. Gender and Number.*
