As a sponsor, you would have a unique opportunity to meet and take part of a conference made up of reputable policy-making individuals from various parts of the state of Texas.

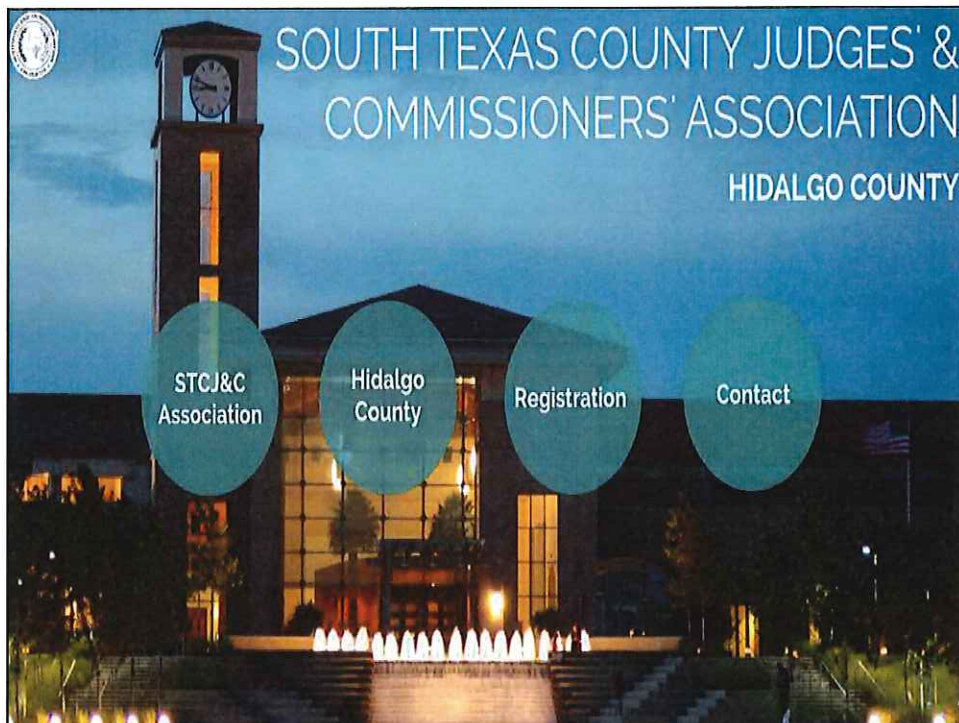
