

**Are there certain contracts that do not require Form 1295?**

Yes. Form 1295 is not required for the following contracts if entered into or amended on or after January 1, 2018:

- (1) a sponsored research contract of an institution of higher education;
- (2) an interagency contract of a state agency or an institution of higher education;
- (3) a contract related to health and human services if:
  - (a) the value of the contract cannot be determined at the time the contract is executed; and
  - (b) any qualified vendor is eligible for the contract;

(4) a contract with a publicly traded business entity, including a wholly owned subsidiary of the business entity;\*

(5) a contract with an electric utility, as that term is defined by [Section 31.002, Utilities Code](#);\* or

(6) a contract with a gas utility, as that term is defined by [Section 121.001, Utilities Code](#).\*
