

**ORDER APPROVING SECOND AMENDMENT AND ADDENDUM  
TO TAX ABATEMENT AGREEMENT EFFECTIVE AS OF  
DECEMBER 13, 2016, BETWEEN HIDALGO COUNTY AND  
WONDERFUL CITRUS PACKING LLC**

**WHEREAS**, the Commissioners Court deemed it to be in the best interest of Hidalgo County, Texas (the “*County*”) to enter into that certain Tax Abatement Agreement between Hidalgo County, and Wonderful Citrus Packing LLC effective December 13 2016 (the “*Original Agreement*”), in accordance with the then effective Guidelines and Criteria for Granting Tax Abatements in Hidalgo County, Texas (the “*Guidelines and Criteria*”), and, in accordance with the Guidelines and Criteria, the County entered into the Agreement with Wonderful Citrus Packing LLC (the “*Company*”);

**WHEREAS**, the Original Agreement was amended by that certain May 30, 2017 Amendment to Tax Abatement Agreement Effective December 13, 2016 between Hidalgo County, Texas and Wonderful Citrus Packing LLC (the “*1<sup>st</sup> Amendment*”, and the Original Agreement as amended by the 1<sup>st</sup> Amendment, the “*Agreement*”);

**WHEREAS**, the Company has requested that the Agreement be amended to clarify certain documentation requirements as it has determined the requested documents do not exist;

**WHEREAS**, the County has determined the applicable tax abatement percentage and the County and the Company wish to fulfill the requirement of the Agreement to enter into an addendum to set the tax abatement percentage; and

**WHEREAS**, the County and the Company now deem it necessary and appropriate to amend the Agreement to so amend the Agreement, all as set forth in that certain *Second Amendment and Addendum to Tax Abatement Agreement Effective December 13, 2016 between Hidalgo County, Texas and Wonderful Citrus Packing LLC* (the “*2<sup>nd</sup> Amendment*”) to be entered into effective June 5, 2018;

**NOW THEREFORE:**

***BE IT ORDERED BY THE COMMISSIONERS COURT OF HIDALGO COUNTY, TEXAS:***

**SECTION 1. APPROVAL OF 2<sup>ND</sup> AMENDMENT.** The 2<sup>nd</sup> Amendment is hereby approved in the form attached hereto as Exhibit “A”, and the County Judge is hereby authorized to execute, and the County Clerk is authorized to attest, the 2<sup>nd</sup> Amendment on behalf of the County and deliver same, and when fully executed and delivered, the 2<sup>nd</sup> Amendment shall become a valid and binding obligation of the County in accordance with its terms.

**SECTION 2 EFFECTIVE DATE.** This Order shall become effective immediately upon the passage hereof.
