RE: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agenda for June 5, 2018. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 11.B. (AI-65222) – Human Resources for Elections

Pursuant to the Fiscal Note, funding for this item is undetermined. We recommend that funding for this action be identified prior to approval by Commissioners Court.

In addition, the position title on the agenda caption for slots T184-T193 (Clerk I) does not agree to the position title for these slots on the CCP Salary Schedule (Clerk). We recommend that the presenter of this item disclose the correction for the record.

Regular Agenda Item 12.G. (AI-65130) – Urban County Program

The agenda caption does not include approval of the attached Work Authorization (WA) No. 1 in the amount of \$15,815.81. We recommend that the presenter of this item request approval of the WA for the record.

Regular Agenda Item 13.A. (AI-65137) – Health & Human Services Department

The Proclamation has an approval date of June 12, 2018. We recommend that the approval date be revised to June 11, 2018 prior to Commissioners Court approval.

Regular Agenda Item 14.A. (AI-65228) – Planning Department

This item is a request for reimbursement of the full contribution from CWL Ltd. for paving of Brushline Road. The County used grant funds to pave Brushline Road. The grant required a cash match of 10%. The County expended \$87,500.19 as a cash match from the R&B Fund. In addition, if the contribution by CWL is considered County monies after it was accepted by Commissioners Court, the Texas Constitution prohibits the County from granting public monies to any individual, association, or corporation whatsoever. We recommend this item be reviewed by legal counsel prior to Commissioners Court approval.
