Ms. Sabrina:

As I understood, Chief Q recommended we receive a draft Inter-local Cooperation Agreement [ILA] so as to have it review as to form by our legal counsel. Has Jim Hogg County been advised of this? How soon can we expect it? The plan of action would remain the same. If we are still at a critical point of moving out adjudicated inmates ready for transport to TDC, we will permit the submission of a requisition for \$49K while the ILA is addressed by HCCC for action. Yes, Ms. Ariana would be the party to send the vendor information to so as to provide to Auditor for set-up in ALIO.
