Your fiscal year 2018 Title V Fee-for-Service (FSS) Child Health and Dental (CHD) grant contract expires on **August 31, 2018**.

To ensure continuity of services to clients, HHSC intends to extend your current fiscal year 2018 contract by 12 months through **August 31, 2019**. The 12-month extension will be for the same contract amount and will incorporate the same performance measures included in your fiscal year 2018 contract as noted below.

Due to an overlap in the state and federal fiscal years for Title V FSS CHD, HHSC is restricted in the amount grantees can be reimbursed for services provided in September 2018. You may bill HHSC for no more than \$2,544.00 for Title V FSS Child Health services provided in September 2018. Please ensure that your billing staff members are aware of this restriction which applies only to the month of September.

A contract amendment will be necessary to implement this contract extension. If you are interested in pursuing this contract amendment, please take the following actions by COB June 18, 2018:

1. Email mike.bright@hhsc.state.tx.us with your intent to continue to provide Title V FSS CHD services through August 31, 2019 (according to the noted specifications).
