RE: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agenda for July 3, 2018. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 3.U. (AI-65425) – I.T. Department

This request is for an interdepartmental transfer (budget amendment) not an intradepartmental transfer (line-item transfer). There are insufficient funds available in object code 583 for the requested transfer. We recommend that the transfer form be revised to include another object code with sufficient funds available for the requested transfer prior to Commissioners Court approval.

Consent Agenda Item 12.E. (AI-65361) – Purchasing Department for Sheriff's Office

Numbered paragraph 1 of Exhibit A (Specification) specifically states the brand name of the weapons to be purchased. However, Section 6.03.02 of the Hidalgo County Purchasing Policy (amended 12/19/2017) states: "No specifications shall be written, which by design exclude legitimate competition between vendors. No brand names shall be utilized unless a disclaimer is used which opens the specification to competing brands of equal or superior quality." We recommend that Exhibit A be revised to remove the brand name or to add language that opens the specification to competing brands of equal or superior quality prior to Commissioners Court approval.

Regular Agenda Item 7.A. (AI-65544) – JP Precinct 1, Place 1

This item is for approval of invoices for supplies purchased without a purchase order. Pursuant to Local Government Code (LGC) Sec. 262.011 (d), only the Purchasing Agent may purchase supplies. Pursuant to LGC Sec. 262.011 (f), the county auditor may not draw and the county treasurer may not honor an electronic transfer, check, or warrant for a purchase unless the purchase is made by the county purchasing agent or on competitive bid as provided by law. The Purchasing Agent has advised that due the emergency nature of the purchase, a purchase order will be issued for the supplies and no action will be requested on this item.

Regular Agenda Item 9.D. (AI-65509) – Human Resources Department

The correct slot number should be T147 instead of T0147. We recommend that the presenter of this item read the correct slot number for the record prior to Commissioners Court approval.

Also, funding for the requested position was not identified. We recommend that the funding be identified prior to Commissioners Court approval.

Regular Agenda Item 14.A. (AI-65508) – I.T. Department

The Wireless Device Request Form for DBM (Budget Office) was not attached for review. We recommend that the Wireless Device Request Form be attached to AgendaQuick prior to Commissioners Court approval.

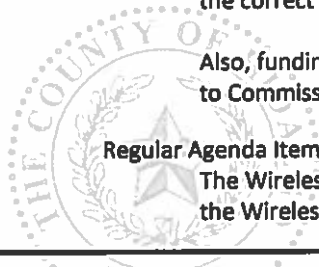
