**CONSENT FOR ENTRY UPON PROPERTY FOR OPERATIONS &  
MAINTENANCE (O&M) PURPOSES**

I, the undersigned, voluntarily consent to allow the U.S. Border Patrol and/or their representatives onto my property, described below, for purposes of assisting the United States Border Patrol, a component of U.S. Customs and Border Protection (CBP), with their operations. This request for consent does not affect the authority of CBP, or persons assisting CBP, to access property in the course of performing their official duties as authorized by law.

I hereby consent or authorize Border Patrol and/or their representatives to enter my property for the purposes of maintaining property infrastructure (including but not limited to: dragging roads, patrolling roads, firebreak roads, boats ramps, lights, fences, levee walls, gates, **camera towers** as well as mowing/shredding).

I understand that the U.S. Border Patrol, and/or their representatives, shall have the right to utilize any required pieces of equipment that will facilitate their maintenance requirements. The U.S. Border Patrol shall take reasonable precautions necessary to try to prevent any environmental or other unintended property damage from occurring due to faulty or improperly maintained equipment. Furthermore, the U.S. Border Patrol and/or their representatives shall reserve the right to introduce, reposition, and remove any and all equipment during the specified period of time in this consent form. I understand that the Border Patrol will remove, within a reasonable period of time, any equipment on the property at the expiration of this agreement. I further grant the U.S. Border Patrol and/or their representatives the right to traverse across my property for the purpose of maintaining adjacent properties, with the understanding that the U.S. Border Patrol will take customary measures to prevent damage to my property.

Consent to allow U.S. Border Patrol and/or their representatives on my property does not waive any rights to seek remedies for any damages that may

result from this agreement. I understand my exclusive remedy for any damage claim is pursuant to the Federal Tort Claims Act.

Consent is valid for a period of two years from the date this document is signed.

I am the legal owner and/or am legally authorized to grant permission to the U.S. Border Patrol and/or their representatives to perform the above stated tasks/requirements on the property described below.
