Section II. Volunteer Expenses	Hidalgo County, Texas will provide the required 10% match of the federal plus non-federal share of the total grant budget. In Section II: Volunteer Expenses of the grantee share is \$13,466 and the CNCS share is \$189,108 for a combined total of \$202,574. In this section of the budget the volunteers will receive 8 hours of recognition leave and 8 hours of accrued leave monthly paid at \$2.65 an hour. Policies and procedures will be established for accrued leave and recognition leave stipends. Please refer to the budget itemized categories for more details.
