Regular Agenda Item 5.B. (AI-65940) – District Attorney's Office

This agenda item is not needed due to action on agenda item 5.A. (AI-66107). The District Attorney's Office has agreed to request no action on this item.

Regular Agenda Item 16.A.2 (AI-66211) – Purchasing Department

The contract under which Work Authorization No. 2 is sought expired on July 18, 2018. In addition, funding for the work authorization was not identified. We recommend that legal counsel be consulted to determine if a supplemental agreement to the contract may be executed to extend the term of the agreement and that funding be identified prior to Commissioners Court approval.
