Dear Diana,

On October 31, 2018, bids were opened for the above referenced project at the Hidalgo County Purchasing Department. A total of four bids were submitted, and they consisted of a base bid item and five alternates. Contractors submitting bids were RG Enterprises, LLC dba G&G Contractors, NM Contracting, LLC, J Pena Construction LTD, and Tri-Gen Construction LLC (see attached Bid Tabulation Sheet). Please note that, when tabulating the bid values, it was discovered that the tabulated base bid amount of NM Contracting, LLC did not match the base bid amount written on their bid page. The source of the discrepancy was a mathematical error on the contractor's part, and they identified the tabulated amount of \$291,287.00 as the correct amount of their bid. Owner has decided to include Base Bid and Alternate No. 1. Based on the total amount for the Base Bid and Alternate No. 1, Hinojosa Engineering, Inc. recommends the project be awarded to the low bidder NM Contracting, LLC in the amount of \$294,647.00.
