On February 4, 2013 at about 9:15 am Investigator Rick Salazar #2334 walked outside his residence to the driveway and checked the passenger door of his unmarked unit # to insure it was locked before leaving to his 10:00 am scheduled Dr's appointment in Harlingen.

Investigator Salazar noticed the passenger door was unlocked. Investigator noticed the glove compartment was opened along with the center console lid. Investigator opened the back door and noticed his tactical gear bag along with a black vest carrier with ballistic insert was also missing. Investigator Salazar noticed that some of

the tactical clothing was taken out of the large black duffle bag and just thrown on the back seat floor board. Investigator Salazar noticed the heavy tactical vest along with knee pads and elbow pads and a ballistic helmet were missing from the back seat.

Investigator Salazar had last seen his tactical gear in the unmarked unit at on Sunday at about noon time when he moved his unit slightly back in the drive way to give room for a secondary vehicle to open its doors.

Investigator Salazar called Weslaco Police Department and filed a Burglary of a Vehicle

Report. No attempt to lift latent finger prints were conducted by Weslaco Police Officer Colunga C-9.

Narcotics Investigator Joel Quintanilla arrived to location later that evening and dusted for latent finger prints.
