FIRST AMENDMENT TO FULL SERVICE DEPUTY CONTRACT
BETWEEN COUNTY OF HIDALGO AND BRIDGEPOINT INSURANCE AGENCY &
PERMIT CENTER, LLC

This First Amendment to Full Service Deputy Contract is made this 5th day of December, 2017 by and between the County of Hidalgo, and on behalf of the Tax Assessor-Collector, hereinafter referred to as "County", and Bridge Point Insurance Agency & Permit Center, LLC, hereafter referred to as "Full Service Deputy."

WHEREAS, County and Full Service Deputy executed that one certain Full Service Deputy Contract dated March 7, 2017 to act as agent of the County for vehicle registration renewals and title transfers (the "Contract"); and

WHEREAS, the parties to the Contract desire to specify the equipment leased to the Full Service Deputy.

NOW THEREFORE, for and in consideration of the services by Full Service Deputy, County and Full Service Deputy hereby mutually agree to the following Amendment to the Contract:

1. The following shall be inserted as the third sentence of numbered paragraph 1 of the Contract:
The description of the Workstation(s) and other equipment leased to Full Service Deputy are described in Exhibit A-1 attached hereto.
2. Exhibit A-1 a copy of which is attached hereto shall be inserted immediately behind Exhibit A of the Contract.
3. Except as modified herein, all terms and conditions of the Contract, as amended, remain in full force and effect. County and Full Service Deputy ratify and confirm the terms and provisions of the Contract as amended.
