Good Morning,

I would like for the county to try and attempt to respond to the concerns. Maybe it needs some clarification. Use the provisions listed in the 23 CFR as a checklist and ensure that they are addressed in some form or another. Note that the provisions can either be referenced or incorporated physically into the language of each contract or subcontract.

For example one of the comments that I have was related to the Title VI. I do not recall being included. If so let me know; I might have missed it. Below is a clip that I obtained from one of our contracts. Does the county feel that this provision has been included physically or referenced in the contract?

**ARTICLE 38. PERTINENT NON-DISCRIMINATION AUTHORITIES**

During the performance of this contract, the Engineer, for itself, its assignees, and successors in interest agree to comply with the following nondiscrimination statutes and authorities; including but not limited to:

**A.** Title VI of the Civil Rights Act of 1964 (42 U.S.C. § 2000d et seq., 78 stat. 252), (prohibits discrimination on the basis of race, color, national origin); and 49 CFR Part 21.

**B.** The Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (42 U.S.C. § 4601)
