Dear Mr. Barboza, Jr.:

Be advised that Hidalgo County will be utilizing the Holdover Provision (Section 1.3) available on contract E-17-321-10-31 (attached) **under the same rates, terms and conditions** with **Miguel Barboza, Jr.**, for the referenced project while procurement process is completed, the County is required, as of **January 1, 2016**, to comply with the **Texas Government Code, §2252.908**, and the rules issued by the **Texas Ethics Commission** found in Title 1, Section 46.1, 46.3 and 46.5 of the Texas Administrative Code. In accordance with these requirements for the type of contract being considered, a business must submit a completed **Certificate of Interested Parties Form 1295**, to the County before the County may enter into a contract with the business entity.

Thus, in order for County staff to process the above referenced extension/renewal; you must complete Form 1295 and file Form 1295 with the Texas Ethics Commission. You can find the 1295 Form through the Texas Ethics Commission at the following website:



In **box 3** of **Form 1295**, provide **EXTENSION CONTRACT No. E-17-321-10-31**. Once completed and filed, "*unsworn declaration*" Form 1295 must be printed, signed and submitted to our office by the deadline stated below.

In order to proceed with "**Holdover**" for referenced project, by **Commissioner's Court on January 29, 2019**, the signed "**HB Form 1295**" and "**Holdover Notice**" must be received in our office completed via email to: sandy.suarez@co.hidalgo.tx.us **by no later than Wednesday, January 14, 2019**. Hidalgo County cannot enter into a contract until Form 1295 is submitted, therefore, failure to timely submit Form 1295 signed, may result in delay of award.
