

**PROCLAMATION DECLARING JANUARY 2019  
NATIONAL SLAVERY AND HUMAN TRAFFICKING PREVENTION MONTH**

**WHEREAS**, National Slavery and Human Trafficking Prevention Month was first proclaimed in 2016 to call attention to the injustice of modern slavery and human trafficking that still occurs in too many places around the world – including right here in the United States; and

**WHEREAS**, as we continue our fight to deliver on the promise of freedom, we commemorate the Emancipation Proclamation, which freed the slaves of the Confederate states on January 1, 1863, and the 13th Amendment, which abolished slavery in 1865. Throughout the month of January 2019, we highlight the many fronts in the ongoing battle for civil rights – including efforts of the Hidalgo County District Attorney’s Office and the Rio Grande Valley Human Trafficking Coalition, which is comprised of Federal, State, and local law enforcement agencies, prosecutors, victim service agencies, and social service providers, who are working to end human trafficking; and

**WHEREAS**, the victims of human trafficking are men and women, adults and children; yet, all are denied basic human dignity and freedom. Victims can be abused in their own countries or find themselves far from home. Whether they are trapped in forced sexual or labor exploitation, human trafficking victims cannot walk away, but are held in service through force, threats, and fear. All too often suffering from horrible physical and sexual abuse, it is hard for them to imagine that there might be a place of refuge; and

**WHEREAS**, we must join together as a community in Hidalgo County to provide a safe haven by protecting victims and prosecuting traffickers. With improved victim identification, medical and social services, training for first responders, and increased public awareness; the men, women, and children who have suffered this scourge can overcome the bonds of modern slavery, receive protection and justice, and successfully reclaim their rightful independence; and

**WHEREAS**, fighting of human trafficking is a shared responsibility. This month, Hidalgo County residents are urged to educate themselves about all forms of modern slavery and the signs and consequences of human trafficking. Together, we can and must end this most serious, ongoing criminal civil rights violation.

**NOW, THEREFORE, BE IT RESOLVED that the Hidalgo County Commissioners Court does hereby proclaim January 2019 as National Human Slavery and Trafficking Prevention Month culminating with National Freedom Day on February 1 and calls upon the people of Hidalgo County to observe this month with appropriate programs and activities and to recognize the vital role we can play in ending human trafficking.**
