Good afternoon Steve,

Precinct 2 is kindly requesting that you draft an amendment to the approved Interlocal Agreement attached for the Pct 2 Las Milpas Road Extension (10th St-McColl Rd) Project. Since approval of the interlocal agreement, the City of Hidalgo has annexed the portion of the road improvement project that was within County Boundaries. This would require an amendment to the ICA to reflect that the project is now 100% within the City Limits of Hidalgo.

This amendment should be pretty simple since Las Milpas Road eventually turns into a County road East of I Rd and it intersects several County Roads making it a connecting link to the County Road System.
