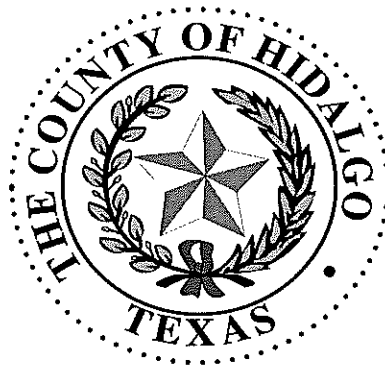

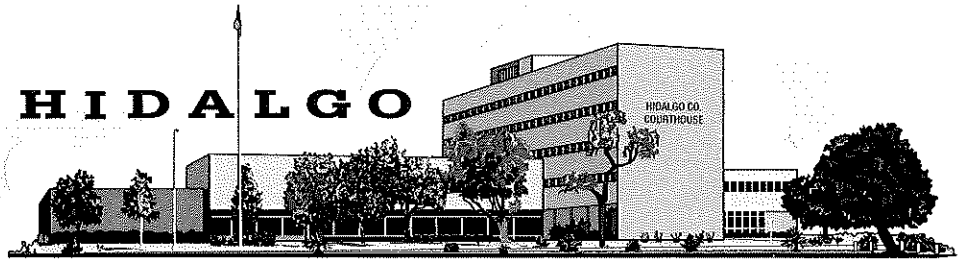

RE: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for March 12, 2019. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 6.A. (AI-69245) – District Attorney's Office

The amended agreement and the appropriation were not attached to AgendaQuick. We recommend that the amended agreement and the appropriation be attached to AgendaQuick prior to Commissioners Court approval. The certification of revenues is pending receipt and review of the amended agreement. The appropriation is subject to the certification of revenues.

Regular Agenda Item 15.D. (AI-69291) – Executive Office

The certification of revenues is pending acceptance of settlement checks by Commissioners Court and receipt of funds by the County Treasurer. The appropriation of funds is subject to the certification of revenues.

Regular Agenda Item 16.B. (AI-69370) – Human Resources

Pursuant to Local Government Code § 152.074, a county with population of 150,000 or more shall provide longevity pay for sheriff's deputies in an amount not less than \$5 a month for each year of service in the department, up to and including 25 years. The Commissioners Court may not approve longevity pay to sheriff's deputies in excess of what is authorized by law.

Regular Agenda Item 16.C. (AI-69363) – Human Resources

The Security Camera Policy contains a typo in section 2.1 (a) – the word "case" should be "cash". We recommend that the corrected Policy be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 16.E. (AI-69246) – Human Resources for Tax Office

Funding for the clothing allowance is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 16.H. (AI-69310) – Human Resources for Domestic Violence Court Grant  
The Personnel Adjustment Request (PAR) forms were not signed/approved by the requesting department, Human Resources, or the Department of Budget and Management. We recommend that the fully executed PAR forms be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 23.A. (AI-69378) – Precinct No. 2  
Numbered paragraph 15 of the Interlocal Cooperation Agreement (ICA) contains blanks. We recommend that ICA with the blanks filled in be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 25.C.2 (AI-69228) – Budget & Management  
The Precinct generally submits documentation (e.g., timesheets, activity logs, equipment usage logs, etc.) for review and verification of the invoice amount to the Drainage District. The certification of revenues is pending review of the documentation. The appropriation of funds is subject to the certification of revenues.

Regular Agenda Item 26.A. (AI-69361) – Purchasing Department  
The Letter of Engagement and Certificate of Interested Parties (Form 1295) were not attached. We recommend these items be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 26.B.1 (AI-69353) – Purchasing Department for Precinct No. 1  
Legal counsel's review of the agreement, the Certificate of Interest Parties (Form 1295), and current ACORD Certificate of Liability Insurance were not attached. In addition, the funding source was not identified. We recommend that these items be attached to AgendaQuick and the funding source be disclosed in the Fiscal Impact section of AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 26.C.2 (AI-69320) – Purchasing Department for Precinct No. 2  
Exhibits C and D referenced in the work authorization are cut-off. We recommend that the complete exhibits be attached to AgendaQuick prior to Commissioners Court approval.
