NARRATIVE: OFFICER JOSE I. GUZMAN #119

ON THURSDAY, 07/19/2007 ABOUT 11:17 A.M., I, OFFICER JOSE I. GUZMAN #119 WAS DISPATCHED TO 510 BALTIC AVENUE IN REFERENCE TO A BURGLARY OF VEHICLE.

UPON ARRIVAL, I SPOKE WITH VICTIM RUBEN ESPINOSA. RUBEN WHO WORKS FOR THE HIDALGO COUNTY SHERIFF DEPARTMENT AS A DEPUTY, STATED HIS VEHICLE HAD BEEN BURGLARIZED AND SEVERAL ITEMS STOLEN. HIS VEHICLE IS A BLACK 1991 JEEP WRANGLER DISPLAYING TEXAS LICENSE PLATES 528-TVF. RUBEN STATED HIS VEHICLE HAD BEEN BURGLARIZED BETWEEN 07/17/2007 AT 11:00 P.M. AND 07/19/2007 AT 11:10 A.M.

HIS VEHICLE WAS PARKED ON THE WESTSIDE OF HIS RESIDENCE ON THE DRIVEWAY FACING EAST. RUBEN STATED THE ITEMS STOLEN WERE A POINT BLANK POLICE VEST, A MOTOROLA PORTABLE RADIO, A MIC FOR THE PORTABLE RADIO AND THE LEATHER POUCH FOR THE PORTABLE RADIO.

RUBEN STATED THE ITEMS WERE TAKEN FROM THE BACK SEAT OF HIS VEHICLE. RUBEN STATED THE VEHICLE WAS NOT SECURED, AS HE IS UNABLE TO LOCK THE DOORS.

I CHECKED THE VEHICLE FOR ANY FORCED ENTRY OR DAMAGE TO THE VEHICLE AND THERE WAS NONE. RUBEN WAS UNABLE TO PROVIDE ANY SUSPECT INFORMATION AND STATED THERE WAS NO VIDEO SURVEILLANCE AVAILABLE. THE VEST AND THE PORTABLE RADIO WERE ENTERED AS STOLEN ITEMS ON THE NCIC/TCIC DATABASE (SEE ATTACHED ENTRY). RUBEN WAS PROVIDED WITH A CASE NUMBER, ADVISED OF COMPLAINT PROCEDURES AND TOLD A REPORT WOULD BE FILED.
