As requested, this office has reviewed the full RFP packet for 2019-062-04-17-HGO regarding NIBRS services and approves it as to form subject to the inclusion of the following recommended modification:

1. Page 3, Non Discrimination section - add the word "where" highlighted below:

NON-DISCRIMINATION: Submitters, during the performance of this contract, will not discriminate or retaliate against any employee or applicant for employment because of race, religion, color, national origin, sex, age, disability or any other protect class under law except where the protected class is a bona fide occupational qualification reasonably necessary to the normal operation of the contractor.

2. Attachment "A" is included twice. One should be removed.

3. Page 25 of Attachment "A" includes a Data Conversion provision. Several question marks are included at the end of a sentence which appears to require additional information. It is recommended to finalize this provision.
