From information provided, this office recommends the following modifications to the specifications for the 2019-062-04-17-HGO:

1. Page 3, Non Discrimination section - replace with the following:

NON-DISCRIMINATION: Submitters, during the performance of this contract, will not discriminate or retaliate against any employee or applicant for employment because of race, religion, color, national origin, sex, age, disability or any other protect class under law except the protected class is a bona fide occupational qualification reasonably necessary to the normal operation of the contractor.

2. Page 5, CONTENTS section - replace with the following provision informing Vendor to fill in Attachment A. (County should include appropriate information regarding County at the top of page one of Attachment A).

CONTENTS: The required contents for the RFP are presented below in the order they should be incorporated into the submitted document. Vendor shall complete and provide information requested on Attachment "A".

3. Page 7, No. 19, replace with the following:

19) Prior to the commencement date of any services provided under this Contract, Company must arrange with Hidalgo County appropriate communication between Precinct Constables and other law enforcement agencies, including but not limited to FBI, DPS and the Hidalgo County Sheriff's Office;

4. Page 7, No. 24, replace with the following:

24) The ability to add or delete Hidalgo County law enforcement agencies as the need arises.
