RE: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for March 26, 2019. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 4.C. (AI-69417) – 2019 Interdepartmental Transfer: Pct. 2 CRC San Juan Youth Facility  
The agenda caption incorrectly states "2018" interdepartmental transfer. This is a 2019 interdepartmental transfer. We recommend that this verbal correction be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 12.D. (AI-69447) – Tax Refunds  
The agenda caption incorrectly states "Falcon International Bank" as the payer for account no. A0800.00.000.1030.10. The correct payor is Texas National Bank. We recommend that this verbal correction be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 13.C. (AI-69397) – Membership Dues: Fire Marshal  
The agenda caption incorrectly states "South Texas Arson Investigators Association" instead of "South Texas Fire Investigators Association." In addition, the agenda caption incorrectly refers to requisition 389837 instead of 389838. We recommend that these verbal corrections be stated for the record prior to Commissioners Court approval.

Consent Agenda Item 16.A. (AI-69596) – Purchasing Department for Sheriff's Office  
The agreement amount exceeds the grant funds available for this purchase. In addition, the requisition incorrectly capitalized user training expenses. Also, the Certificate of Interested Parties (Form 1295) was not attached. We recommend that funding for the amount in excess of the grant funding be identified and that the revised requisition and Form 1295 be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 9.F. (AI-69420) – Human Resources for Elections  
Pursuant to the Fiscal Note, funding for the requested personnel actions is undetermined. We recommend that funding be identified prior to Commissioners Court approval.
