Good Morning Ms. Ortiz,

As requested, this office reviewed the procurement packet for RFB 2019-O47-04-17-HGO: Purchase of EN-1 Road Stabilizer Material and approves it as to form subject to the inclusion of the recommended modification(s) below:

1. Remove extra Proposer's Affidavit -Exhibit "J" which does not include the procurement identification.
2. Replace paragraph 17 Commitment of Current Revenues section of the attached draft agreement with the following, which will be recommended for future contracts. It incorporates language required by Tex. Loc. Govt. Code §271.903 in the event it is an acquisition, including lease, of real or personal property.

Commitment of Current Revenues Only. In the event that, during any term hereof, the Commissioners Court does not appropriate sufficient funds to meet the obligations of County under this Agreement, County may terminate this Agreement upon ninety (90) days written notice to Company. County agrees, however, to use reasonable efforts to secure funds necessary for the continued performance of this Agreement. The parties intend this provision to be a continuing right to terminate this Agreement at the expiration of each budget period of County. **Agreements for the acquisition, including lease of real or personal property under Tex. Loc. Govt. Code §271.903:** In the event that, during any term hereof, the Commissioner's Court does not appropriate sufficient funds to meet the obligations of County under this Agreement, County may terminate this Agreement upon ninety (90) days written notice to Company, County agrees, however, to use a best efforts attempt to obtain and appropriate funds for payment of the Agreement. The parties intend this provision, if applicable, to be a continuing right to terminate this Agreement at the expiration of each budget period of County in accordance with Tex. Loc. Govt. Code §271.903 (Vernon Supp. 1996).
