RE: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for April 9, 2019. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Regular Agenda Item 13.C. (AI-69847) – Executive Office

The RGV Hispanic Chamber of Commerce is requesting a donation of \$2,500. Article 3, Section 52 of the Texas Constitution prohibits counties from granting public money to a corporation such as a chamber of commerce. However, the County may enter into an MOU with the RGV Chamber of Commerce to accomplish a public purpose the County is already authorized to perform. The MOU and legal counsel's review and approval of the MOU were not attached. We recommend that the MOU and legal counsel's approval of the MOU be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.B. (AI-69825) – Human Resources for Elections

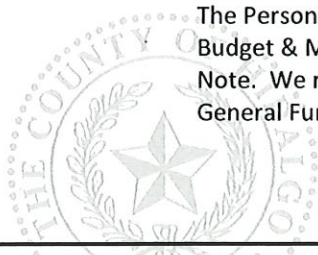
The Personnel Adjustment Request (PAR) forms were not attached. We recommend that the fully executed PAR forms be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.D. (AI-69818) – Human Resources for County Court at Law No. 3

The Personnel Adjustment Request (PAR) forms were not approved/signed by the requesting department, Human Resources or Budget & Management. We recommend that the fully executed PAR forms be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.E. (AI-69838) – Human Resources for District Attorney's Office

The Personnel Adjustment Request (PAR) forms were not approved/signed by Human Resources or Budget & Management. In addition, funding in the General Fund is undetermined pursuant to the Fiscal Note. We recommend that the fully executed PAR forms be attached to AgendaQuick and funding in the General Fund be identified prior to Commissioners Court approval.

Regular Agenda Item 14.F.1 (AI-69800) – Human Resources for District Attorney’s Office

The Personnel Adjustment Request (PAR) forms were not approved/signed by Budget & Management. We recommend that the fully executed PAR forms be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.F.2 (AI-69800) – Human Resources for District Attorney’s Office

The requested changes require the grantor’s approval of a budget adjustment. In addition, the Personnel Adjustment Request (PAR) forms were not approved/signed by Budget & Management. Also, slot 080-002-A168 for employee 192082 should be 080-002-A123 and slot 080-002-A169 for employee 219983 should be 080-002-A168. We recommend that the grantor’s approval of the budget adjustment be obtained; the fully executed PAR forms be attached to AgendaQuick; and corrections to the slot numbers be stated for the record prior to Commissioners Court approval.

Regular Agenda Item 14.I. (AI-69794) – Human Resources for Precinct No. 3

Pursuant to the Fiscal Note, funding for the reclassification is undetermined. We recommend that funding be identified prior to Commissioners Court.
