

**NOTICE OF PUBLIC HEARING OF THE COMMISSIONERS
COURT OF HIDALGO COUNTY, TEXAS
IN CONSIDERATION OF PLAN TO RENAME A PUBLIC ROAD
LOCATED WITHIN THE LAS BRISAS ESTATES SUBDIVISION**

Notice is hereby given that the Commissioner's Court of the County of Hidalgo, Texas (the County) will be accepting public comments regarding a request by the residents and tenants of the Las Brisas Estates Subdivision to rename Las Brisas Circle, a public road located within the Las Brisas Estates Subdivision, in accordance with Texas Transportation Code § 251.013.

The County is considering renaming the street, in honor of Mr. Alfonso Flores, a resident of Las Brisas Estates Subdivision, who is a decorated United States Armed Forces Veteran who served during the Vietnam War and was awarded three (3) Bronze Star Medals, One (1) Purple Heart Medal, one (1) Vietnam Service Medal, one (1) Vietnam Campaign Medal, one (1) Vietnamese Cross of Gallantry With Palm Medal and the Combat Infantry Badge. In honor of Mr. Alfonso Flores's dedicated service, the County of Hidalgo Commissioner's Court recommends that:

- Las Brisas Circle shall be renamed to Alfonso Flores Drive

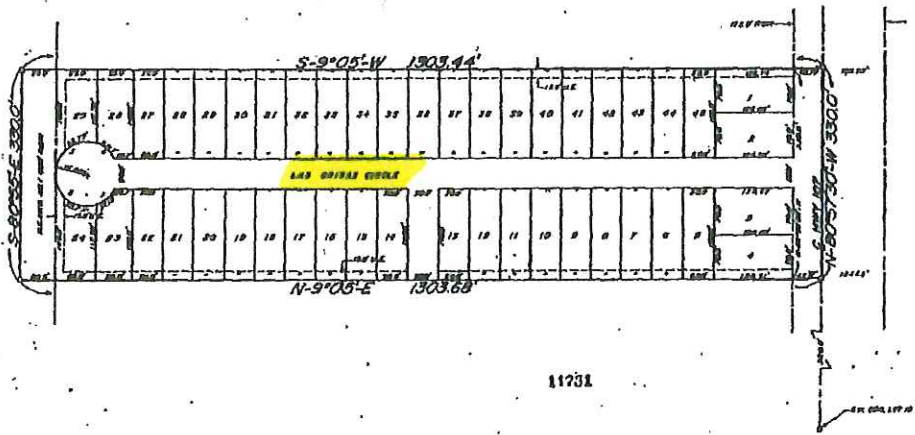

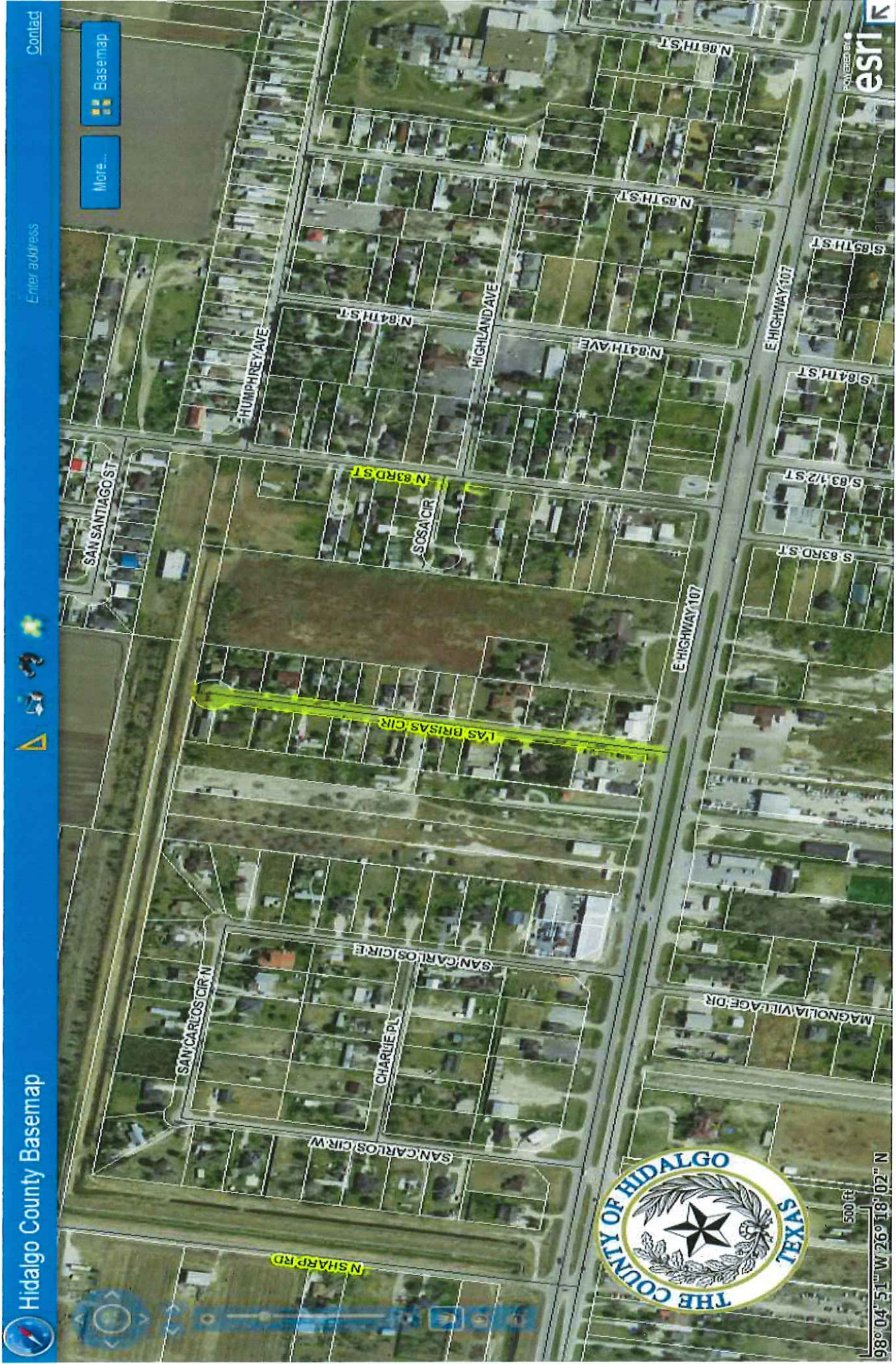

**AN ORDER TO RENAME LAS BRISAS CIRCLE IN LAS BRISAS ESTATES
SUBDIVISION TO ALFONSO FLORES DRIVE**

WHEREAS, the subdivision plat for the Las Brisas Estates Subdivision, recorded on March 30, 1983, provides an explicit dedication for public use of all streets within the subdivision; and

WHEREAS, an interior road named by this plat as Las Brisas Circle has been explicitly dedicated to use by the public through that dedication; and

WHEREAS, residents from this Subdivision have presented the Commissioners Court with a petition proposing that this road be renamed as Alfonso Flores Drive; and

WHEREAS, Mr. Alfonso Flores, a resident of Las Brisas Estates Subdivision, is a decorated Veteran of the United States Armed Forces who served during the Vietnam War; and

WHEREAS, Mr. Alfonso Flores was awarded three (3) Bronze Star Medals, one (1) Purple Heart Medal, one (1) Vietnam Service Medal, one (1) Vietnam Campaign Medal, one (1) Vietnamese Cross of Gallantry With Palm Medal and the Combat Infantry Badge; and

WHEREAS, Texas Transportation Code § 251.013 permits the commissioners court of a county to enter an order adopting a name for a public road after holding a public hearing and providing notice of such a hearing; and

WHEREAS, the Commissioners Court held a hearing on this day, after providing the public with at least two (2) weeks of notice before the date of this hearing; and

WHEREAS, after holding this hearing, the Commissioners Court is of the opinion that the name of this public street should be changed to honor Mr. Flores's dedicated service;

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS COURT of HIDALGO COUNTY that:

1. The recitals set forth in this Order are true and correct.
2. The Hidalgo County Commissioners Court hereby re-names Las Brisas Circle to Alfonso Flores Drive in honor of Mr. Flores's service in the United States Armed Forces.
