**Regular Agenda Item 13.D. (AI-69948) – Human Resources for Facilities Management**

Pursuant to the Fiscal Note, funding for new position is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

**Regular Agenda Item 13.F. (AI-69983) – Human Resources**
