ON SEPTEMBER 14, 2004 THE COUNTY COMMISSIONERS COURT GRANTED FINAL APPROVAL WITH FINANCIAL GUARANTEE TO SECURE THE INSTALLATION OF SEVENTY (70) SEPTIC TANK SYSTEMS. ON SEPTEMBER 11, 2014 THE DEVELOPER REPLACED THE ORIGINAL LETTER OF CREDIT NO. 090204 WITH A CASH DEPOSIT IN THE AMOUNT OF FORTY THOUSAND EIGHT HUNDRED DOLLARS (\$40,800.00) TO SECURE THE INSTALLATION OF THE REMAINING FIFTY ONE (51) SEPTIC TANK SYSTEMS.

THE DEVELOPER IS REQUESTING A PARTIAL REIMBURSEMENT IN THE AMOUNT OF EIGHT HUNDRED DOLLARS (\$800.00) FROM THE CASH DEPOSIT. THIS REFLECTS THE INSTALLATION OF ONE (1) ADDITIONAL SEPTIC TANK SYSTEM. ATTACHED IS A LETTER FROM THE HIDALGO COUNTY HEALTH DEPARTMENT STATING THAT TWENTY (20) OUT OF SEVENTY (70) SEPTIC TANKS HAVE BEEN INSTALLED, INSPECTED, AND CAN BE EXPECTED TO FUNCTION SATISFACTORILY.

STAFF HAS NO OBJECTION TO THE APPROVAL FOR REIMBURSEMENT OF THE CASH DEPOSIT IN THE AMOUNT OF EIGHT HUNDRED DOLLARS (\$800.00) FOR THE AFOREMENTIONED IMPROVEMENT.
