Re: Agenda Observations

Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for May 7, 2019. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 10.C. (AI-70268) – Purchasing Department for Precinct No. 1

The draft contract and legal counsel's approval of the draft contract are not attached. We recommend that these items be attached to AgendaQuick prior to Commissioners Court approval.

Consent Agenda Item 10.FF. (AI-70128) – Purchasing Department for IT Department

The invoice number on the agenda caption is incorrect – it should be Application No. 2. We recommend that the presenter read the correct invoice number for the record prior to Commissioners Court approval.

Regular Agenda Item 8.D. (AI-70148) – Sheriff's Office

The grant requires a minimum 20% cash match. Funding for the cash match has not been identified. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 15.J. (AI-69966) – Human Resources for Elections Department

Pursuant to the Fiscal Note, funding for the personnel actions is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 15.K. (AI-70099) – Human Resources for Sheriff's Office

Pursuant to the Fiscal Note, funding for the re-grade is undetermined. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 23.E. (AI-70095) – Precinct No. 3

The agreement is dated March 18, 2019 instead of May 7, 2019. We recommend that the agreement date be revised to May 7, 2019 and re-attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 25.B.2 (AI-70232) – Budget & Management

Amount certified by County Auditor is \$113,628.79. The amount to be appropriated is \$121,746.68. The difference is coming from unassigned fund balance.
