Dear Judge and Commissioners:

We conducted a limited scope review of the Regular and Consent Agendas for May 21, 2019. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 4.C. (AI-70426) – 2019 Interdepartmental Transfer: Pct. 4 CRC Memorial

The amount of the transfer should be \$701.73 instead of \$701.43 as noted on the agenda caption. We recommend that the correction be announced for the record prior to Commissioners Court approval.

Consent Agenda Item 9.C. (AI-70446) – Tax Refunds

Agenda item 9.C. is a duplicate of 9.B. (AI-70453). We recommend that no action be taken on this duplicate item.

Consent Agenda Item 13.A. (AI-70400) – Health & Human Services Department

The invoice is for lodging and meals for RAM (Remote Area Medical) staff during Operation Lone Star from July 21-28, 2019. The current MOU with RAM is not applicable since it only goes into effect if a large-scale public health emergency is declared. We recommend that legal counsel review this item and determine if a specific MOU with RAM for Operation Lone Star is needed prior to Commissioners Court approval.

Regular Agenda Item 5.D. (AI-70450) – County Judge's Office

The registration form was not attached. We recommend that the registration form be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 7.A. (AI-70495) – HIDTA Task Force

The reprogram request was already submitted. Item 1 should be approval to ratify the submission of the reprogram request. We recommend that the presenter clarify this for the record prior to Commissioners Court approval.

Regular Agenda Item 14.B. (AI-70431) – Human Resources

The revised position inventory list was not attached. We recommend that the revised inventory list be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.D. (AI-70349) – Human Resources for District Attorney’s Office

Funding for slot 080-002-0151 is undetermined per the Fiscal Note. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 14.G. (AI-70409) – Human Resources for WIC

Funding for the temporary part-time positions is pending approval of Summer Food Program Grant award and certification of revenues for the award. The award letter will be presented to Commissioners Court on the next meeting.

Regular Agenda Item 14.H. (AI-70417) – Human Resources for Precinct No. 4

Funding for the requested personnel actions is undetermined per the Fiscal Note. We recommend that funding be identified prior to Commissioners Court approval.

Regular Agenda Item 16.D. (AI-70382) – Health & Human Services Department

Certification of revenues is pending federal award information from the grantor. Appropriation is subject to certification of revenues. Request for information was submitted to grantor on May 20, 2019.

Regular Agenda Item 16.H. (AI-70299) – Health & Human Services Department

The appropriation is not attached. We recommend that the appropriation be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 18.B. (AI-70418) – IT Department

The agenda caption contains a typo. Per the Wireless Device Request Form, the new service plan for office use is the 4G Custom Nationwide Unlimited Minutes, Messaging, Email and Data at \$39.99 plus \$5.00 taxes/fees per month. We recommend the presenter announce the correction for the record prior to Commissioners Court approval.

Regular Agenda Item 27.C.1 (AI-70491) – Purchasing Department for Sheriff’s Office

The Certificate of Interested Parties (Form 1295) is not attached. We recommend that Form 1295 be attached to AgendaQuick prior to Commissioners Court approval.
