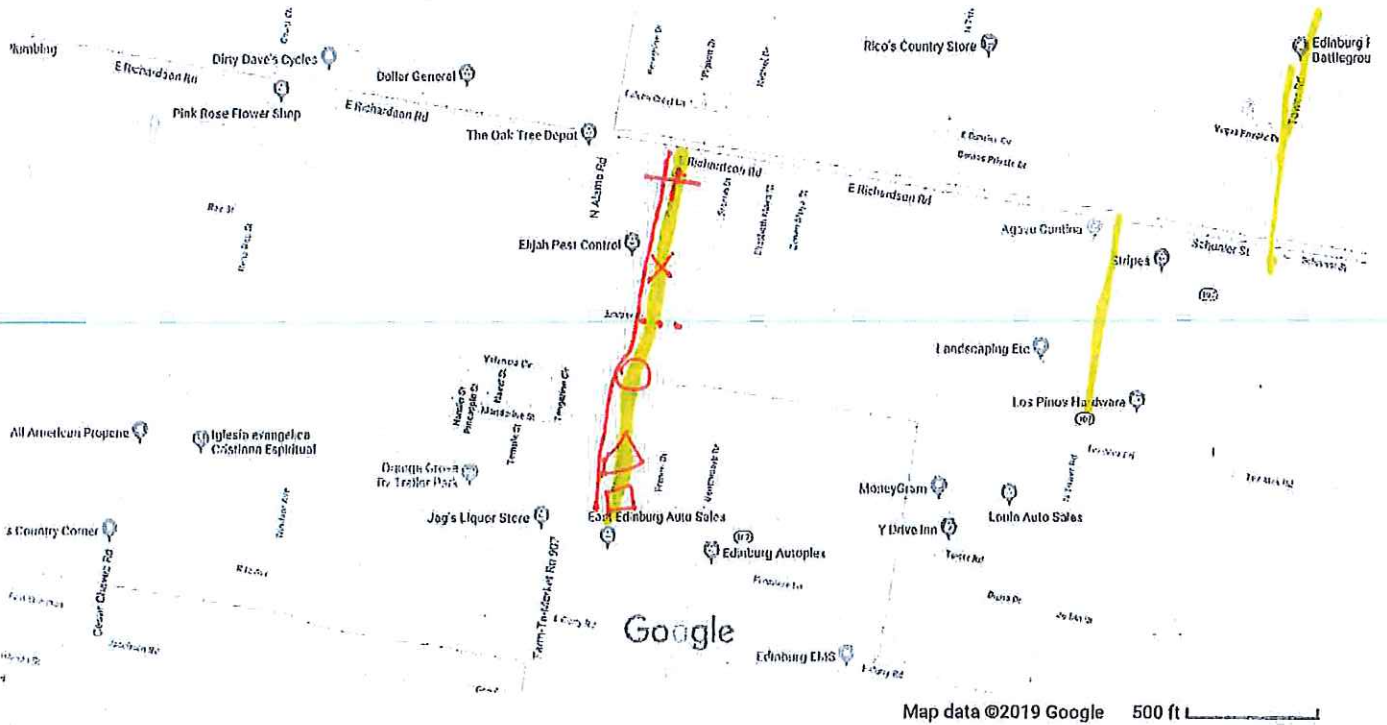

Google Maps Notes - Poncaire Drive

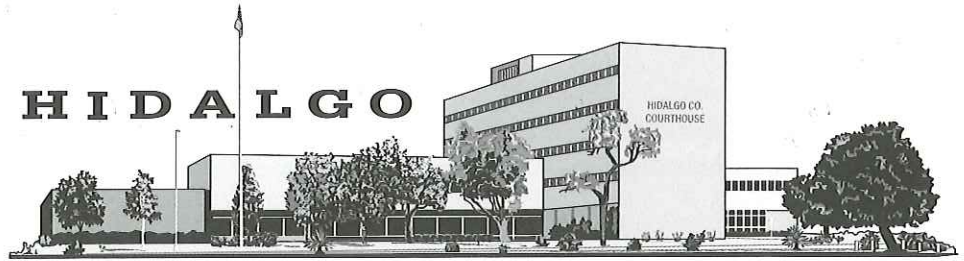
