Good afternoon Mr. Ochoa,

I spoke with Mr Madero a couple of weeks ago reminding him that back in May of 2018 we were requesting to name the Private Easement to our house, but the easement was under litigation and did not qualify.

And to also inform him that the pending lawsuits on the Private Right of Way Road Easement on the South side of 9 mile line, West of Ware Rd is **finally** over and has been disposed, in which we now can request a name for the Private Easement. Mr. Madero also said that I could use the same petition request from last year.

The petitioners have all agreed on the name **Blue Indigo Private Dr.**

And we have a few other requests to add under that sign due to the following safety issues that are arising:

1. Dead End//No Thoroughfare/No Turn-around -With all of the new developing going on in this area there has been an influx of traffic that seems to think this easement is a "thoroughfare" and because the easement has no turn around, its hard for traffic to turn around and go back out.
2. Slow/Children at Play - Because of the influx of traffic, there has been on occasion traffic driving way to fast down the easement; one of the residents almost got hit as he was walking out of his gate into the easement. Most of the residents have children all under the age of 15 years who play and ride their bikes in the area as well.

Good Afternoon Mr. Madero,

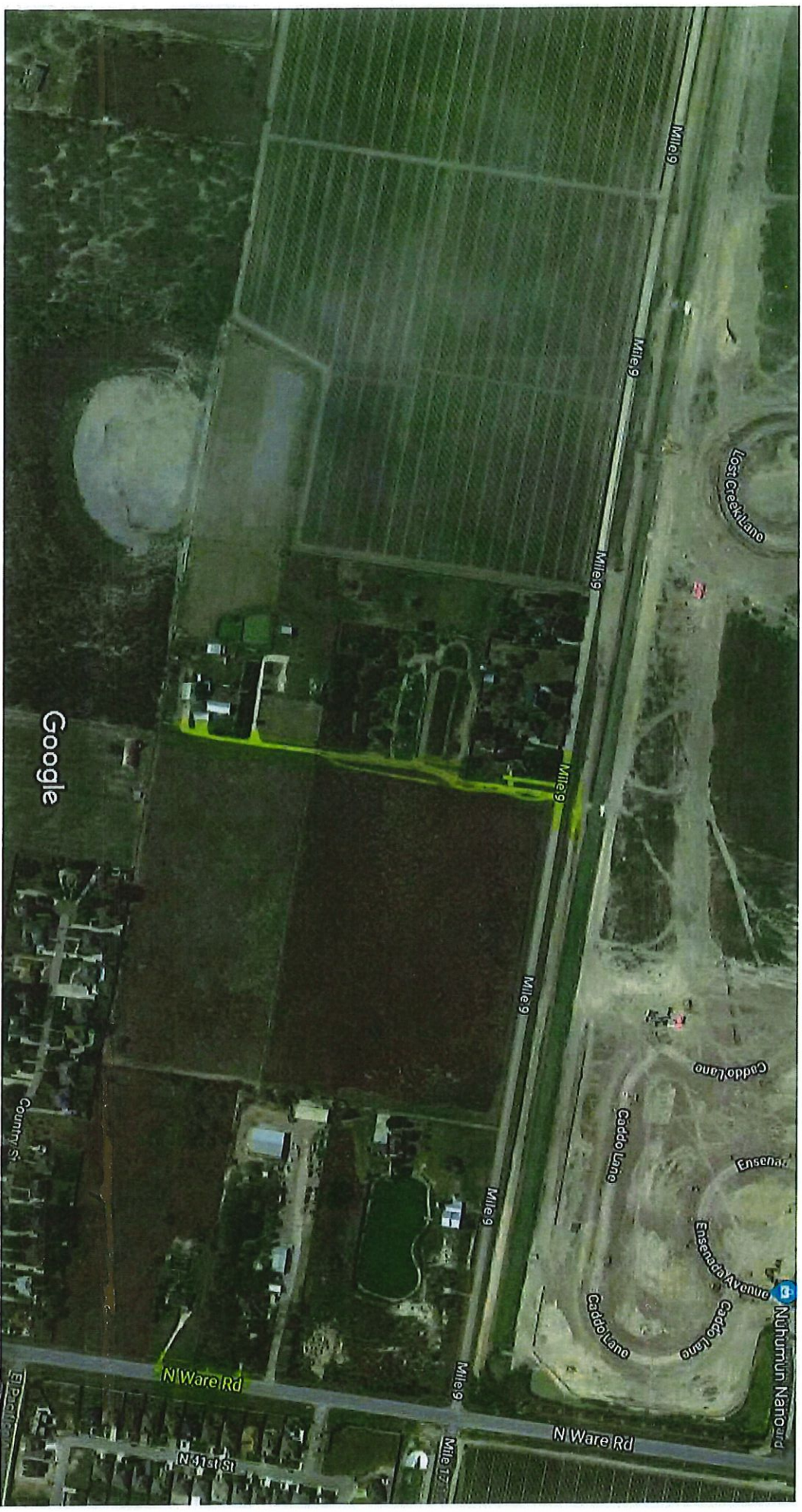
