Please let me know if you will allow us to host this event there ASAP so we can start scheduling everything.

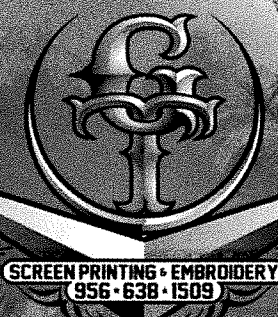

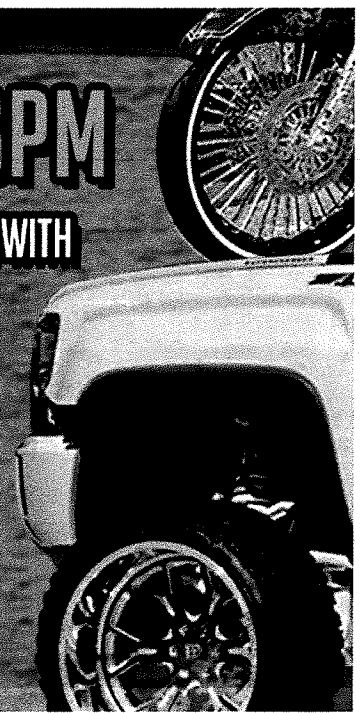
