Attached is our invoice for this billing period. The following tasks were accomplished this month.

- **May 2, 2019** – Mr. Behrooz Badiozzamani, P.E. and Mr. Jacinto Garza, P.E. attended the HCMPO Technical Advisory Committee (TAC) Meeting and coordinated with Hidalgo County MPO Representative Commissioner Eddie Cantu.
- **May 16, 2019** – The HCMPO Policy Meeting was cancelled.
- **Throughout the month of May, L&G Engineering staff**
 - Both Mr. Jacinto Garza, P.E. and Mr. Behrooz Badiozzamani, P.E. have been providing MPO guidance with the projects with Commissioner David Fuentes as it relates to funding for the FM 88, FM 493 and future projects such as SH 495 and Nolana Extensions. Additionally they have been coordinating the provision of additional federal funding to the Mile 10 project. Continued guidance has also been provided to Commissioner Joe Flores for funding associated for two (2) new Overpasses in La Joya and the Extension from FM 1925 to Jara Chinas.
 - Mr. Anthony Garza coordinated administrative amendments to the MTP to avoid delays in the processing of agreements with TxDOT on the Mile 10 (Pct. 1) and FM 2220 (Pct. 4) projects.
 - Provided technical support for Commissioner Eddie Cantu regarding the Merger of the Rio Grande Valley MPOs and attended multiple meetings with commissioners to provide updates on the status.
 - Provided technical support for revisions to Hidalgo County projects in anticipation of the update to the Metropolitan Transportation Plan (MTP) and concurrent development of the TxDOT 2020 Unified Transportation Plan as it relates to projects in FY 2029 of the MTP. L&G staff reviewed all four commissioners' projects to ensure no delays to project development occurred as a result of the MTP/UTP update.
