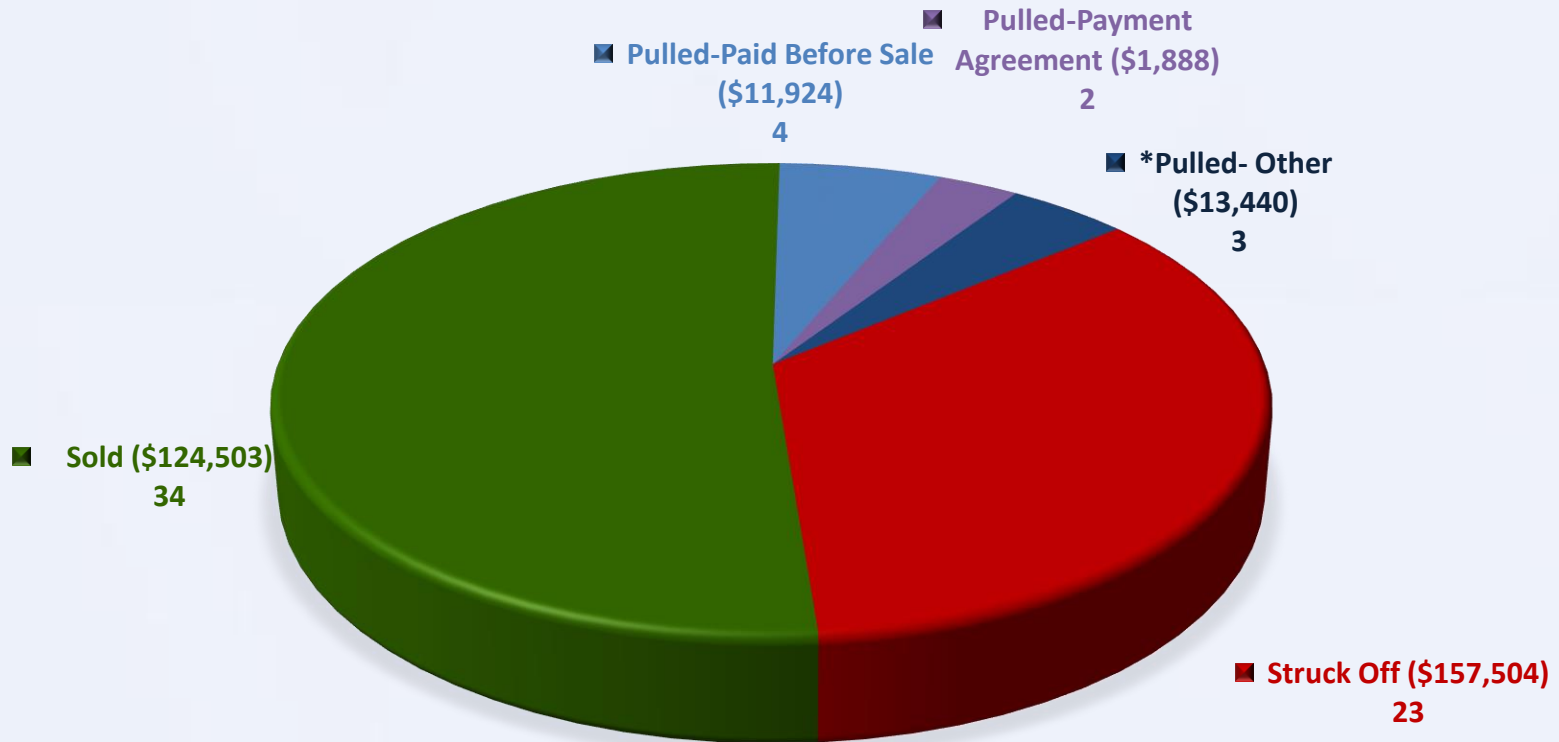

Collection Comparison July 2018—March 2019

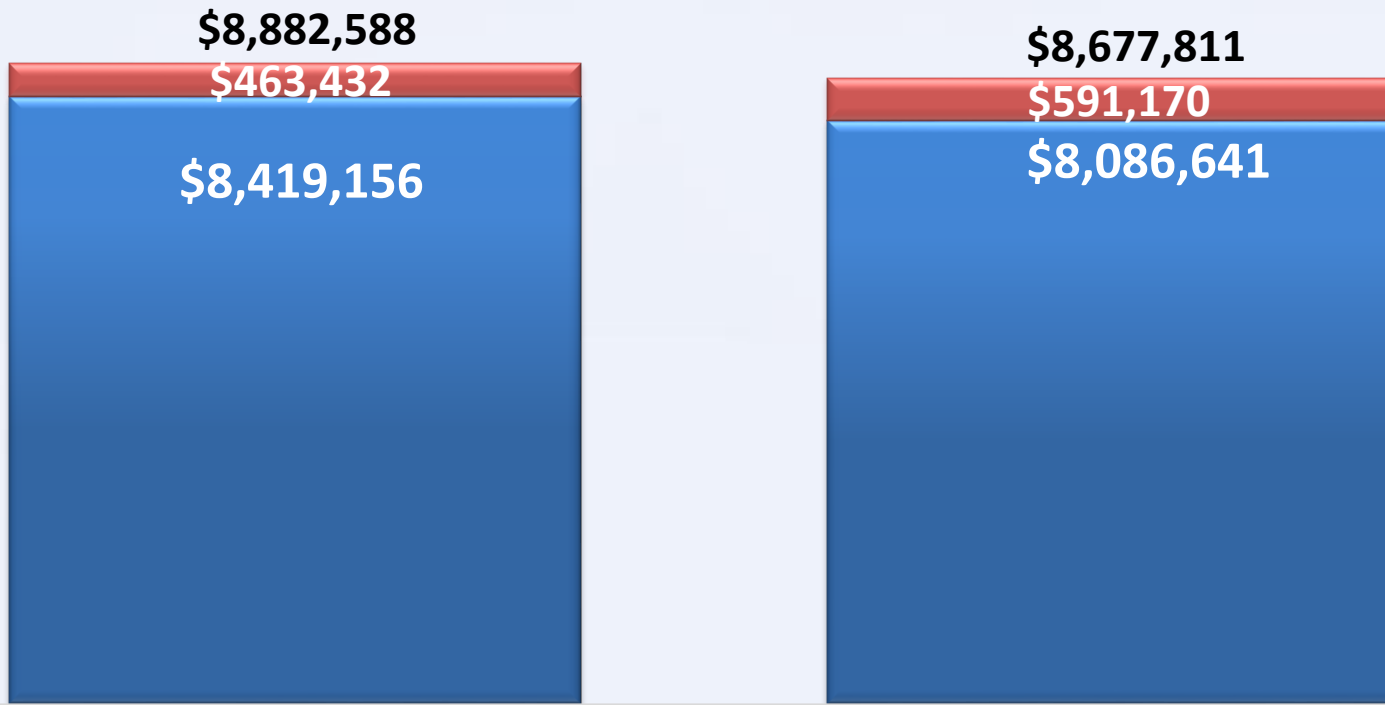

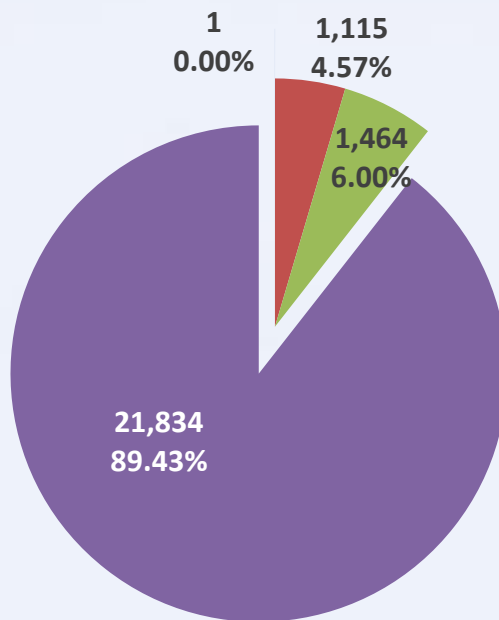

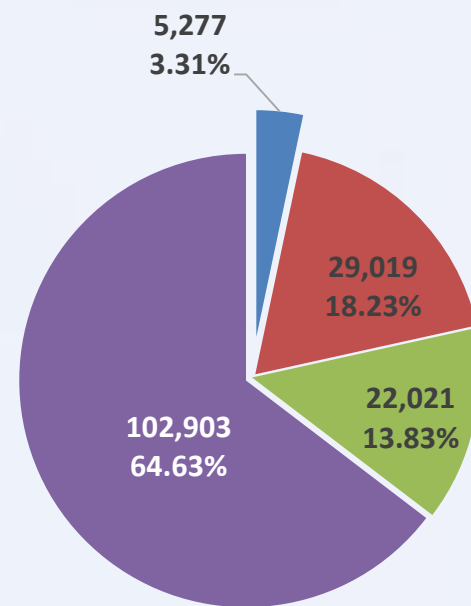

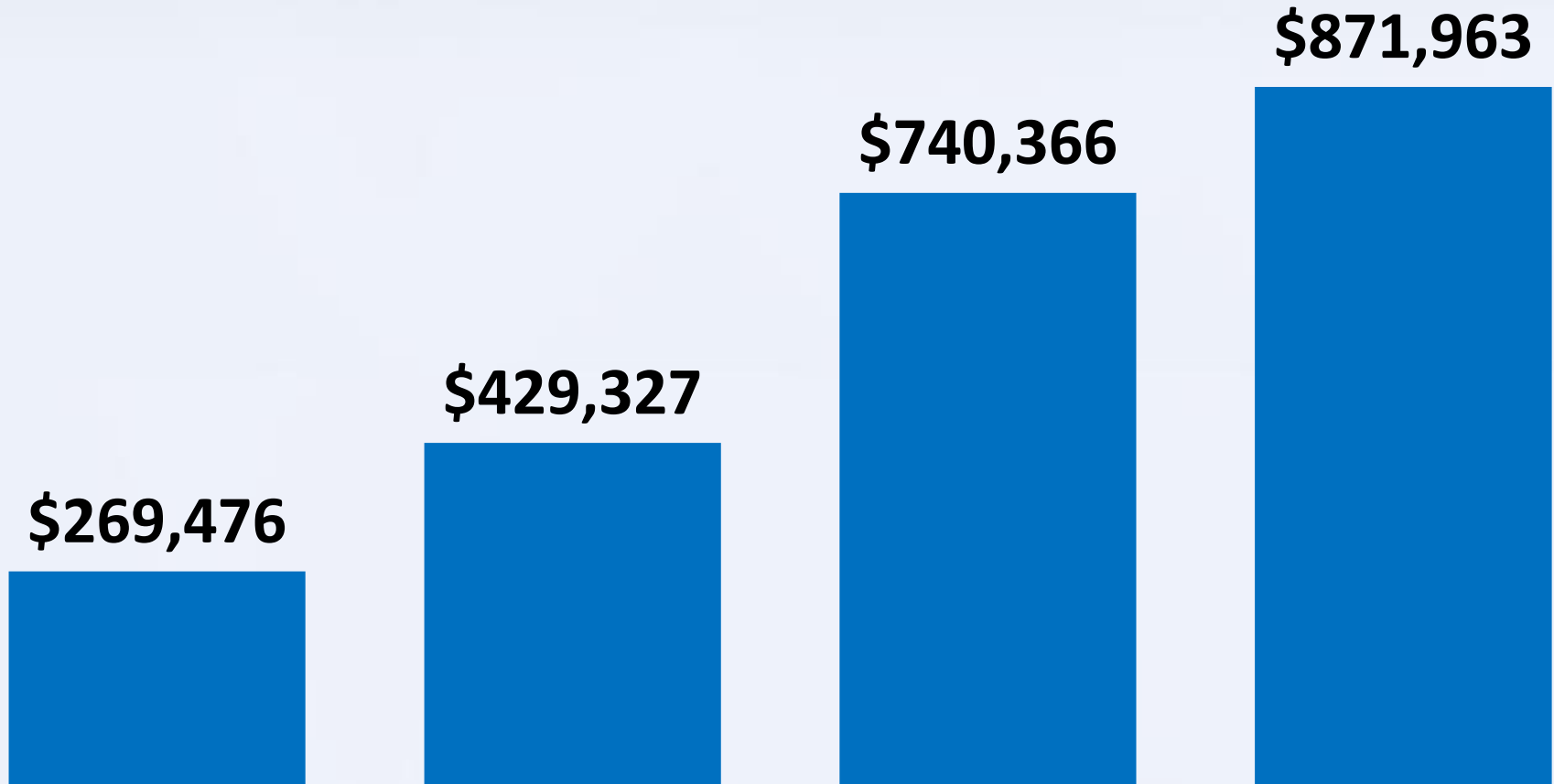

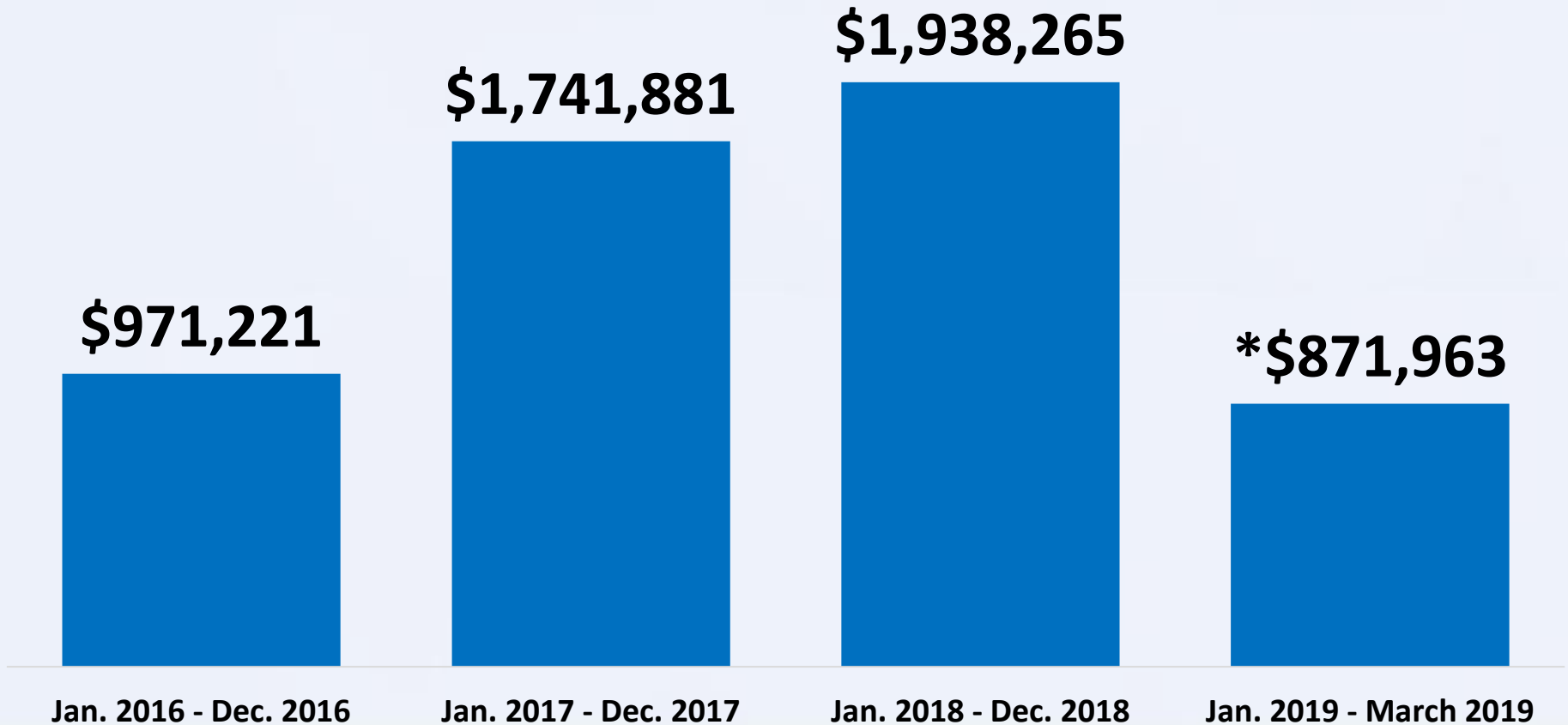
