Acknowledgement of Obligations for 2019 "Road to Recycling" Regional Tire Collection Project July 20, 2019

Lower Rio Grande Valley Development Council (LRGVDC) is pleased to announce the 2019 "Road to Recycling" Round 2 Tire Collection Event. All the counties and cities across the Valley were invited to participate. Once again, we are allocating resources to this effort to cost share the expense and LRGVDC will be responsible for tire disposal fees only. LRGVDC has capped each participating entity to remain within budget.

LRGVDC has reviewed data of previous tire events and has determined the **Hidalgo County Precinct #2 (HCP #2) tire disposal budget cap of \$2,100 dollars**. This amount will pay for 6 containers estimating 1,500 regular sized tires. LRGVDC will pay up to the proposed amount mentioned but will not exceed, unless funds become available but will be at the LRGVDC discretion to evaluate and disburse these funds.

HCP #2 will be responsible to pay any remaining disposal fee balance if an overage occurs (*e.g. tire disposal budget cap \$4,000, total invoice \$4,500, City is responsible for \$500*). UTW will invoice the county directly and provide LRGVDC a copy. LRGVDC will then pay HCP #2 invoice balance to the county directly. If HCP #2 does not exceed the budgeted cap the invoice amount indicated will be paid with no overage fees due by the county.

HCP #2 should have staff at each drop-off site and transport containers to UTW's facility (3005 N. Val Verde, Donna, TX. 78537). UTW will open for service Saturday, July 20th and Monday, July 22nd. **All container(s) MUST be taken to UTW no later than Monday, July 22, 2019.**

If HCP #2 chooses to participate on July 20th tire cleanup event, this form must be signed acknowledging the roles, responsibilities and conditions of payment.
