Mr. Crain,

Good morning and hope all is well with you. I'm making contact in hopes that you can assist with amending the agreement attached below. In June of 2018 Hidalgo County along with the City of Weslaco entered into agreement for an overlay project commencing at the intersection of Westgate (mile 6 west) running east to the intersection of Mile 10 to FM 88 (mile 5). This project was never initiated and requires amendment to the amount and time.

We're kindly requesting the agreement reflect the updated total project amount of 110,209.56 of which will be mutually divided by weslaco and Hidalgo County. The amount each party will be responsible for will be in the amount of \$55,104.78 and it be paid upon execution of this agreement. We're also kindly requesting that we have at least 180 days to complete this project. Please also ensure that we're able to bill for overages at end of project.

We're hoping to have this for approval in next week commissioners court for approval. I thank you in advance for all the assistance. Below you will find the original fully executed agreement for your review with the most recent cost estimate and limits. Please feel free to contact me for any question or concerns.
