

**FIRST AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT
BY AND BETWEEN
HIDALGO COUNTY, TEXAS
AND
STARR COUNTY, TEXAS
REGARDING THE HOUSING OF PRISONERS IN STARR COUNTY DETENTION
FACILITY**

This Amendment to the Interlocal Agreement is made and entered into this **06th** day of **August, 2019**, by and between **STARR** County, Texas, a political subdivision of the State of Texas (hereinafter referred to as “**STARR**”) and **HIDALGO** County, Texas a political subdivision of the State of Texas (hereinafter referred to as “**HIDALGO**”), pursuant to the provisions of the Texas Interlocal Cooperation Act, as follows:

WITNESSETH:

WHEREAS, the Counties of **HIDALGO AND STARR** entered into an Interlocal Agreement dated **July 18, 2018**, wherein **STARR** agreed to house prisoners for **HIDALGO** (both males and females) in the Starr County Detention Facility and in compliance with jail regulations as promulgated by the Texas Commission on Jail Standards; and

WHEREAS, the Agreement was for a one year term with automatic one year renewals and both parties have agreed to restate and continue to carry out the services as outlined in the Agreement;

NOW THEREFORE, HIDALGO AND STARR in consideration of the terms and provisions set forth herein, agree to the following Amendment to the Agreement:

1. Numbered Paragraph 2 shall be deleted in its entirety and the following shall be substituted in lieu thereof:

“**HIDALGO** shall pay **STARR** a daily prisoner-housing fee of **SIXTY DOLLARS AND NO CENTS (\$60.00)** per prisoner a day. The day the prisoner is "booked in" will be counted and charged. The day the prisoner is "booked out" will not be counted or charged. **STARR** will mail **HIDALGO** a monthly, itemized invoice showing the actual number of **HIDALGO** prisoner days in that month and the daily **HIDALGO** prisoner count. **HIDALGO** will remit the full amount of the invoice to the Starr County Auditor's Office within thirty (30) days of receipt thereof.”

2. Except as modified herein, all terms and conditions of the Agreement, as amended, remain in full force and effect and **STARR** and **HIDALGO** ratify and confirm the terms and provisions of the Agreement, as amended.
