General Terms and Conditions:

- This agreement extends one (1) year and renews automatically month-to-month after the first 12 months. Either party may terminate this agreement with 30 days written notice to the other party.
- Customer may cancel agreement after initial 30 days at no extra charge. If Customer cancels after the first 30 days, and while still within the 12-month period, a Termination-Recovery fee applies equal to the cost of the monthly rental fee.
- After the 12 month, customer must give a 30-day notice if planning to terminate the contract. Recovery fee charges may be changed by Partsmaster upon 30-days written notice to Customer.
- Monthly payments are due upon receipt of invoice. If Customer fails to make a payment when due, interest may be charged at 1% per month until the unpaid amount is paid.
- Partsmaster will provide to Customer the Equipment, product kit and Torrent cleaner for normal usage-for the above monthly fee.
- Customer will use the Equipment for washing ordinary oils and greases from machine parts only at the Ship to location only.
- Customer is responsible for properly connecting and grounding the Equipment to electrical and compressed air supplies.
- If the Equipment is relocated or moved, Customer is solely responsible for properly and legally moving, transporting and re-installing the Equipment and all associated risks.
- Customer is responsible for the proper storage and disposal of all liquid, waste or other byproducts generated by its use of the Equipment.
- All Equipment, except waste drum, remains the property of Partsmaster at all times. Upon termination of this Agreement, Customer must immediately return all Equipment, except waste drum, to Partsmaster or the monthly fee will continue. The returned Equipment must be cleaned and may contain no hazardous materials.
- Partsmaster is not responsible for damages caused by improper use or connection of the Equipment, movement, relocation or re-installation of the Equipment, Customer's negligence or for any consequential, indirect or incidental damages, including business interruption.
- Partsmaster is not responsible if Customer causes damage to the Equipment or its loss. Customer must notify Partsmaster in writing within 24 hours if the Equipment is damaged or is not properly functioning or is relocated. Partsmaster, at its sole discretion, will repair damages to the Equipment, unless caused by Customer. Customer must suspend use of the Equipment until repaired.
- Customer will not add anything to drum and cleaning solution, or modify the Equipment in any way.
