Hi Azael,

The WIC Program is required to obtain USDA approval for any single item purchase whose acquisition cost is greater than \$25,000, or any purchase that is adding value to real property. In the case of the cameras, the unit price for each camera and installation does not exceed the \$25,000 threshold and having the cameras on the property does not necessarily add value to the property since they are removable. For those reasons, we are not required to obtain USDA approval.
