**AMENDMENT TO WORK AUTHORIZATION #4 AGREEMENT
C-18-142-05-08**

THIS Amendment to WORK AUTHORIZATION #4 is made on this 8th day of **October, 2019**, by and between the **COUNTY OF HIDALGO, TEXAS** ("County"), acting herein by and through Commissioner's Court, and **Half Associates, Inc.**, a Texas Corporation, hereinafter called the "Engineer";

WHEREAS Engineer and County entered into an agreement (C-18-142-05-08) ("Original Agreement") on or about May 8, 2018, in which Engineer agreed to provide professional "On-Call" Engineering Services for "Building Repairs, Renovations, Alteration, Additions and/or Other Related Services to County Owned Buildings" for projects located within **Hidalgo County Precinct No. 4** as described in the Agreement;

WHEREAS Engineer provided "Engineer's Contract Rates" as part of the Original Agreement to be applicable to work authorizations issued under the same;

WHEREAS Work Authorization No. 4 was issued through the Original Agreement for engineering services related to the Hidalgo County Sheriff's Office Bus Barn;

WHEREAS a discrepancy exists between fees provided on the Work Authorization No. 4 and the fees provided as part of the Original Agreement, which the parties wish to remedy;

WHEREAS, the Agreement allows the parties to modify or amend the Contract terms by mutual written agreement; and

WHEREAS, County and Contractor now desire to amend the terms of services;

NOW, THEREFORE, for and in consideration of the terms and provisions set forth herein, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged,

County and Engineer hereby agree to the following Amendment to the Agreement:

1. The section entitled PART 2. ESTIMATED COST shall be removed and substituted and replaced with the following:

PART 2. ESTIMATED COST Engineer shall be paid for services in accordance with rates established in the original agreement (C-18-142-05-08 - "Engineer Contract Rates"). Engineer shall outline the estimated cost for services under this Work Authorization in the Estimated Cost Proposal attached as **Exhibit D**. *See attached "Cost Proposal" incorporated herein for all purposes.*

2. Engineer shall revise the form it submitted as part of Work Authorization No. 4 entitled "Fee Schedule-HCSO Bus Barn" to reflect corrected fees. *See attached revised form incorporated herein for all purposes.*
3. Engineer shall revise **Exhibit D** "Cost Proposal" to the Work Authorization No. 4 to reflect calculations using the corrected fees; *See attached revised Exhibit "D" incorporated herein for all purposes.*
4. Except as modified herein, all terms and conditions of Work Authorization No. 4, as amended, remain in full force and effect. COUNTY and ENGINEER ratify and confirm the terms and provisions of the Work Authorization as amended herein.
