We conducted a limited scope review of the Regular and Consent Agendas for January 14, 2020. Our review consisted of selected agenda items. Based on our review, the following observations were made:

Consent Agenda Item 6.D. (AI-73898) – 2020 Interdepartmental Transfer: Precinct No. 4

This agenda item is a duplicate of agenda item 6.E. (AI-73943). The Precinct has advised that no action will be requested on this item.

Regular Agenda Item 6.A. (AI-73939) – District Attorney's Office

A requirement of the grant is that the applicant (County) be registered with the National Institutes of Health (NIH). We recommend that confirmation of the registration with the NIH be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 13.B. (AI-73834) – Executive Office

Legal counsel's review and approval of the revised agreement is not attached. We recommend that legal counsel's approval of the agreement be attached to AgendaQuick prior to Commissioners Court approval.

Regular Agenda Item 14.B. (AI-73955) – Human Resources Department for Precinct No. 1

Funding is undetermined pursuant to the Fiscal Note. We recommend that funding be identified prior to Commissioners Court approval.
