Dear Judge Cortez,

As many counties are currently preparing their FY 2020 budgets, we wanted to provide this notice of the amount of FY 2020 membership dues for Hidalgo County for the Texas Conference of Urban Counties. **This is not a bill. Do not pay this amount at this time.**

The dues formula for FY 2020 is the same as it was for FY 2019, \$3,000 per county and \$0.025 per resident of the county contained in the most recent county-by-county population estimates published by the US Census Bureau.

The amount of dues for FY 2020 for Hidalgo County will be \$24,648.

Obviously, dues sustain the Conference of Urban Counties and allow us to bring county leaders together to discuss shared challenges, explore new ideas, and better our policy positions through collective analysis.

But the value achieved through membership in the Conference of Urban Counties is multiplied by active participation. If you have not recently attended one of our meetings – Policy Committee, Membership Luncheons, education roundtables, or the annual Education & Policy Conference – I encourage you to pencil us on your calendar in 2020. Attendance is the best way to engage with your colleagues to learn about, and to share knowledge about, issues that are of vital importance to our communities.
