GENERAL RELEASE

As a representative of the County of Hidalgo, TX, I, Valde Guerra, in consideration of the sum of \$832 dollars, and .96 cents (\$832.96) do hereby for the County of Hidalgo, personal representatives and assigns, release and forever discharge Gemaire and any other person, their subsidiaries, affiliates, agents, successors, heirs, administrators, assigns, corporations or entities, responsible or potentially responsible for liability from any and all claims, demands, damages, actions, causes of action, liens, including Medicare, costs, expenses and loss of services, arising from any act or occurrence up to the present time, and particularly on account of all property damage, disability, bodily injury, loss or damages of any kind sustained as a result of the accident that occurred on or about 11/07/2019 involving County of Hidalgo Texas F150 XLT Ford Truck #594.

To procure payment of the said sum, I hereby declare: that I am more than 18 years of age and of sound mind; that no representation about the nature and extent of said damages, injuries and/or disabilities made by any physician, attorney or agent of any party hereby released, nor any representations regarding the nature and extent of legal liability or financial responsibility of any of the parties released, have induced me to make this settlement; that in determining said sum there has been taken into consideration not only the ascertained damages, injuries, and disabilities, but also the possibility that the damages and/or injuries sustained may be permanent and progressive and recovery therefrom uncertain and indefinite, so that consequences not now anticipated may result from the said accident. The undersigned agrees to hold the released parties harmless and indemnify them from any claims asserted by any third parties or lien holders, including, but not limited to, all medical providers and any other insurance carriers, against the proceeds of this settlement.

I understand that the parties hereby released admit no liability of any sort due to said accident and that this payment and settlement in compromise is made to terminate further controversy respecting all claims for injuries that have been asserted because of said accident. This release contains the entire agreement between the parties hereto and the terms of this release are contractual and not a mere recital.

I FURTHER state that I have carefully read the foregoing release, understand the contents thereof and sign the same as my own free act and deed, intending to be legally bound thereby.
