As requested, this office reviewed the bid packet for RFB No.: 2020-047-00-00-TDL, and approves it as to form subject to the following modifications:

1. Statement of Credentials - replace No. 5 with the following:

PERFORMANCE OF WORK BY BIDDER: Except as otherwise provided, the general contractor/bidder shall perform no less than eighty percent (80%) of the work with his

own organization, and no more than twenty percent (20%) of the work may be subcontracted.

2. Draft Contract -

- Replace the first paragraph with the following:

This Agreement entered into this ____ day of _____, 2020, by and between the County of Hidalgo (hereinafter called the "OWNER") and _____ (a corporation) (a partnership) (an individual) of _____, State of Texas, hereinafter called "CONTRACTOR". The County's procurement packet and Contractor's response are incorporated herein for all purposes.

- Contract signature page - move the attorney approved as to form signature line to the bottom of the page and change to my name.

3. Revise the Supplemental General Conditions Form as follows:

- remove the number "5" from: "SC-12.01B.2~~5~~ & B.3 in the middle of the page.
- Replace the italicized language in section SC-6.10 with the following:

The owner qualifies for the state and local tax exemption in the purchase of certain materials and equipment. Other exemptions as per 34 TAC §3.287 and related law may apply.

- Remove the section entitled General Prevailing Wage Legal Requirements as this provision is referenced in other sections.
