**AMENDMENT TO
CONTRACT #C-2020-088-02-26**

This **AMENDMENT** to the **CONTRACT** is made this 7th day of **APRIL of 2020** by and between **HIDALGO COUNTY, TEXAS** (the "COUNTY") and **DAVILA & ASSOCIATES, INC.** (the "Contractor"). **WHEREAS**, COUNTY and CONTRACTOR entered into a Contract on February, 26, 2020, (the "CONTRACT"), in which the CONTRACTOR agreed to provide the County "Translation/Interpretation Services for all Hidalgo County Commissioner's Court (may include Hidalgo County Drainage District Board of Directors) meetings as described therein, as well as other services as described in the CONTRACT; and

WHEREAS, the COUNTY due to certain circumstances now requires further clarification of the services to be provided by the CONTRACTOR and hereby requires the amendment of the Contract; and

WHEREAS, the COUNTY desires the CONTRACTOR to provide the services and rates as described and provided by CONTRACTOR in the CONTRACT as **Exhibit "A" Scope of Services**, and **Exhibit "B" Fee Schedule**, respectively; and

WHEREAS, the COUNTY and CONTRACTOR now desire to amend the CONTRACT as hereinafter provided.

NOW THEREFORE, for and in consideration of the terms and provisions set forth herein, for good valuable consideration, the receipt and sufficiency of which are hereby acknowledged, COUNTY and CONTRACTOR hereby agree to the following amendment to the CONTRACT

1. Exhibit "A" – Scope of Services, shall be amended herein to include sign language interpreter services,
2. Exhibit "B"- Fee Schedule, shall be amended to now include any fees for additional services said sign language interpreter services at \$75.00 per hour with a minimum of two (2) hours, subject to the limitations of the Contract.

3. Except as modified herein, all terms and conditions of the CONTRACT, as amended, remain in full force and effect. COUNTY and CONTRACTOR ratify and confirm the terms and provisions of the CONTRACT as amended herein.
